The Embassy of Italy presents its compliments to the Ministry of Foreign Affairs of the People's Republic of Bangladesh and has the honor to inform that the Turin–Aosta 2028 Winter Sports Championship will be held in Italy from 10 to 24 January 2028, while the Adaptive Winter Championship will take place from 5 to 14 February 2028.

In accordance with Article 49 of the Schengen Visa Code, a streamlined entry procedure has been established for accredited participants and officials who are subject to visa requirements for entering the Schengen area.

Under this system, entry authorization is not issued as a traditional visa sticker in the passport. Instead, a digital entry clearance is embedded within a secure QR code printed on the official Championship Identification Pass issued to each accredited individual.

This pass, when presented together with a valid travel document, allows entry through external Schengen borders, effectively replacing the conventional visa format.

It should be noted that these authorizations permit multiple entries, and their validity may be verified electronically at Schengen border control points.

Please find attached an informational leaflet regarding the Identification Pass, including details of its security features and verification process. The Embassy of Italy kindly requests the Esteemed Ministry to circulate this material among the relevant border authorities and concerned airline operators.

The Embassy of Italy avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the People's Republic of Bangladesh the assurances of its highest consideration.

COMMUNIQUE

The Embassy of Italy urges all applicants to follow the official procedures when submitting visa applications or requesting consular services.

Applicants are advised that submitting forged documents, as well as presenting false claims, is a crime and can lead to serious legal consequences.

Additionally, the high rate of falsified documents received forces this Embassy to conduct thorough investigations, which further extend the time required to process visa applications and consular services.

The Embassy wishes to stress that it is not affiliated to any agent and strongly advises applicants not to rely on intermediaries who claim to have privileged influence over the visa decision-making process. VFS Global is the only authorized agency for collecting applications, receiving payments and returning passports. Any payment to unlicensed agents or unauthorized individuals can result in considerable financial losses.

The Embassy strongly advises applicants to carefully check the authenticity of every document they intend to submit, as well to rigorously verify the correctness of the information contained therein. Applicants are reminded that they are fully responsible for the authenticity and veracity of the submitted documentation.

Applicants are kindly requested to regularly visit both the Embassy's and VFS Global's websites for updates and instructions, and to consult the list of required documents of each specific visa or consular service.

Dear Mr. Alfa Beta,

With reference to your quotation dated April 21st, 2026, which is part of the present order, the Embassy of the Republic of Italy in Dhaka has the honour to inform that Gamma Limited has been selected to provide the furniture specified in the aforementioned quotation.

The terms and conditions will be as follows:

- 1) The total amount to be paid by the Embassy will be BDT 500.000,00 (Five Hundred Thousand) only, included VAT and Tax.
- 2) The supply must be provided within 15 (fifteen) days from the signing of this order.
- 3) All payments will be made through Bank transfer in the name of Gamma Limited. The payments will be executed as follows:
 - BDT 250.000,00 (Two Hundred Fifty Thousand) only, at the signing of the present contract as advanced payment;
 - BDT 250.000,00 (Two Hundred Fifty Thousand) only, as balance payment. This payment will be made within 5 working days from the reception of the agreed supply.
- 4) The Embassy of Italy in Dhaka reserves the right to terminate this agreement by giving 3-days' notice due to any breach of the aforementioned terms and conditions.

We trust that the above terms and conditions will be acceptable and look forward to receiving the specified furniture.
